- Paper must be in Single Column Format and all paragraphs must be both justified.
- The entire document should be in Times New Roman.
- Figures and Tables must be centered in the column. They must be numbered using Arabic numerals with captions. Graphics may be full SOLID FILL colours.

(Text Size 10 point). The heading of the References section must not be numbered. Number the reference items consecutively in square brackets (e.g. [1]). Multiple references are each numbered with separate brackets (e.g. [2], [3], [4]–[6]). Please use Regular and Italic styles to distinguish different fields as shown in the following examples:

- For Journal Research Article, see reference [1]
- For Doctoral Dissertation, see reference [2]
- For Research Book, see reference [3]
